Subject: European Council meeting (23 and 24 June 2022)
– Draft conclusions

In accordance with Article 3(1) of the Rules of Procedure of the European Council, delegations will find attached the draft conclusions prepared by the President of the European Council, in close cooperation with the member of the European Council representing the Member State holding the six-monthly Presidency of the Council and with the President of the Commission.

I. WIDER EUROPE

1. The European Council held a strategic discussion on the European Union's relations with its partners in Europe. It discussed the proposal to launch a European Political Community.

[What – who?]

2. The aim is to offer a coordination political platform for European countries across the continent. It could concern the Western Balkans, the associated countries of our Eastern Partnership and other European countries with whom we have close relations.

[Why?]

3. The objective would be to foster political dialogue and cooperation to address issues of common interest so as to strengthen the security, stability and prosperity of the European continent.
4. Such a framework will not replace and be complementary to existing EU policies and instruments, notably enlargement, and fully respect the European Union's decision-making autonomy.
5. Building on this first exchange of views, the European Council will revert to the issue.

II. UKRAINE

1. The European Council discussed the Russian war of aggression against Ukraine in its different dimensions. The European Council reiterates that it firmly stands with Ukraine and that the European Union will continue providing strong support for Ukraine's overall economic, military, social and financial resilience, including humanitarian aid.

2. The European Council resolutely condemns Russia's indiscriminate attacks against civilians and civilian infrastructure, and urges Russia to immediately and unconditionally withdraw all its troops and military equipment from the entire territory of Ukraine within its internationally recognised borders. International humanitarian law, including on the treatment of prisoners of war, must be respected. Ukrainians, notably children, forcibly removed to Russia must be immediately allowed to return safely. Russia, Belarus and all those responsible for war crimes and the other most serious crimes are to be held to account for their actions, in accordance with international law. The adoption of the sixth package of sanctions further intensifies pressure on Russia to end its war against Ukraine. The European Council calls on all countries to align with EU sanctions.
3. The European Union remains strongly committed to providing further military support to help Ukraine exercise its inherent right of self-defence against the Russian aggression, its defence of its territorial integrity and sovereignty. [To this end, the European Council calls for a further increase of military support under the European Peace Facility.]
4. Russia, by launching its war against Ukraine, is solely responsible for the global food security crisis it provoked. The European Council urges Russia to immediately stop targeting agricultural facilities and removing cereals, and to unblock the Black Sea, in particular the port of Odesa, so as to allow the export of grain and commercial shipping operations. The European Council supports the efforts of United Nations Secretary General Guterres to this end.

5. The European Council calls on the Commission and the Member States, building on the FARM initiative as well as UN and G7 initiatives in particular, to step up their efforts:
 - (1) to support developing countries to reorient, where necessary, their supply chains,
 - (2) to accelerate the delivery of the relevant Team Europe flagship initiatives agreed at the recent European Union - African Union summit which seek to develop food production, strengthen agricultural productivity and agri-business capacity on the African continent
 - (3) to launch an EU initiative to support the development of fertiliser manufacturing capacity and alternatives in developing countries.

IV. WESTERN BALKANS

6. The European Union expresses its full commitment to the unequivocal EU membership perspective of the Western Balkans and calls for the acceleration of the EU integration process.
7. The European Council invites the Commission, the High Representative and the Council to further advance the progressive integration between the European Union and the region already during the enlargement process itself in a reversible and merit based manner.
8. The European Council recalls the importance of reforms notably in the area of rule of law and in particular those related to the independence and functioning of the judiciary and the fight against corruption. It calls also on the partners to guarantee the rights and equality of treatment of minorities.

10. The European Council reaffirms the urgency of making tangible progress in resolving outstanding bilateral and regional disputes, inter alia the Belgrade-Pristina Dialogue to support the normalisation of relations between Serbia and Kosovo¹.
11. The European Council welcomes the political agreement reached on 12 June 2022 by the Leaders of Bosnia and Herzegovina in Brussels which is needed for the stability and full functioning of the country and responding to the aspiration of the people. It calls on all political Leaders in Bosnia and -Herzegovina to implement swiftly the commitments set out in it, the implementation of which will allow the country to advance decisively on its European path and towards EU candidate status.

V. ECONOMIC ISSUES

12. The European Council generally endorses the integrated country-specific recommendations as discussed by the Council, thus allowing the conclusion of the 2022 European Semester.
13. The European Council welcomes the fulfilment by Croatia of all the convergence criteria as set out in the Treaty. It endorses the Commission's proposal that Croatia adopt the euro on 1 January 2023 [and invites the Council to adopt swiftly the relevant Commission proposals].

VI. CONFERENCE ON THE FUTURE OF EUROPE

14. The European Council takes note of the proposals set out in the Report on the outcome of the Conference submitted to the three co-Presidents. The Conference has been a unique opportunity to engage with European citizens.
15. An effective follow-up to this report is to be ensured by the institutions, each within their own sphere of competences and in accordance with the Treaties. The European Council notes that work has already been undertaken in this regard.
16. It recalls the importance of ensuring that citizens are informed of the follow-up to the proposals made in the Report.
