FRI, 20 September	Commission transmission of <b>candidates' CVs and mission letters.</b>
MON, 23 September	Commission transmission of the <b>candidates' declarations of interests.</b>
TUE, 1 October	<b>Extraordinary CCC meeting:</b> <ul style="list-style-type: none"> <li>- Adoption of the <b>common questions</b> for the candidates to the new Commission;</li> <li>- Adoption of the recommendation on the <b>timetable</b> for the confirmation hearings;</li> <li>- Adoption of the recommendation on the <b>division of responsibilities</b> among committees.</li> </ul>
WED, 2 October	<b>CoP meeting:</b> <ul style="list-style-type: none"> <li>- <b>Decision</b> on the <b>timetable</b> and on the <b>division of responsibilities</b> for the confirmation hearings.</li> </ul>
THU, 3 October am	Deadline for the committees to submit their specific <b>written questions.</b>
THU, 3 October pm	<b>Extraordinary CCC meeting or written procedure:</b> <ul style="list-style-type: none"> <li>- Adoption of the <b>programme</b> of the confirmation hearings together with the <b>questionnaires</b> to candidates.</li> </ul>
FRI, 4 October	<b>CoP meeting:</b> <ul style="list-style-type: none"> <li>- <b>Approval of the programme</b> of the confirmation hearings and of the <b>questionnaires.</b></li> </ul> <p><b>Written questionnaires</b> are sent to the Commission.</p>

THU, 10 October	Deadline for <b>JURI scrutiny</b> and sending letters to committees responsible.
FRI, 11 October	Deadline for the Commission to send the Commissioners-designates' <b>replies to written questions</b> in EN (translations in all languages to be sent at least 48h before each hearing).
