

## Programme for the confirmation hearings of the Commissioners-designate (Alternative 2)

4 November - 12 November 2024

Principles: The proposed programme follows the order of the presentation of Commissioners-designate such as submitted by the Commission, with the following adaptations:

- the hearing of Commissioner-designate Šeřčovič, in charge of relations with Parliament, is scheduled as first;
- the hearings of the Commissioners in which the BUDG and CONT committees are involved should take place on 7 November in the afternoon due to budgetary trilogues and conciliation meetings, which are a treaty obligation;
- the programme avoids that committees responsible have hearings in parallel.
