Dear President,

I. Unfinished business from the ninth parliamentary term

Following your letter of 25 July 2024, Parliament's committees have considered the unfinished business from the ninth parliamentary term (both under the Ordinary Legislative Procedure and other procedures) and those files where Parliament has already adopted its position, in accordance with Rules 250 (“unfinished business”), 62 and 86 (“renewed referral to Parliament”) of Parliament's Rules of Procedure.

On 8 October 2024, the Conference of Committee Chairs (CCC) took note of the committees' indications and invited me to provide you with the results of the screening exercise.

II. Recommendation on the modalities of cooperation among committees for unfinished files

In your above-mentioned letter you invited the CCC to prepare a recommendation to enable the Conference of Presidents to take a decision on the transitional arrangements¹ that should apply to legislative procedures for which Parliament did not adopt a position before the end of the previous parliamentary term and for which the previous Rules 56, 57 or 58 were applied.

It is important to recall that these unfinished files are subject to a complex procedural situation. They have been referred to committees, some of which have started work under the previous version of our Rules of Procedure. Now they should be continued under the new Rules, which have introduced profound changes to the referral procedure and the modalities of cooperation among committees.

Against this background, I have taken an approach that respects the new Rules on the revised joint committee procedure (Rule 59) and the new form of opinions (Rule 57), while at the same

time following an inclusive methodology given the specificity of the transitional period. In this context, my recommendation should not be considered to set a precedent for future allocations of legislative proposals, which will be referred under our new Rules of Procedure.

The recommendation takes into account the state of procedural progress of each file and is based on the following principles:

1. Committees' responsibilities under Annex VI remain the key reference for assessing the competence of a committee for a file;
2. Joint committee procedures granted under the old Rules should remain joint committee procedures under the new Rules; new joint committee procedures are recommended for files subject to the former associated committee procedure for which, under the new Rules, no single lead committee with "prevailing" competence could be identified;
3. Where, in the past, a committee decided not to draw up an opinion on a file, this decision should be considered valid and the committee should not be re-introduced as opinion-giving committee;
4. Committees should exceptionally be allowed to re-do their opinions in the new term in cases where the lead committee did not adopt its report during the previous term, as otherwise these opinions would not be retained in the resumed procedure;
5. In line with the transitional arrangements, the former associated committee procedures should only remain active where the lead committee has adopted its report before the end of the previous term. This approach should also apply where the 1st reading was concluded (Annex I, part B);
6. Budgetary assessments under Rule 58 should replace previously granted opinions by the BUDG Committee in cases where the proposal has implications on the Union budget
7. For NLE and APP files, committees listed for opinion should retain their status and not be de-listed, unless a committee has decided already not to draw up an opinion (see point 3);

Please find the details for each file in the following enclosed annexes:

- for files under **the ordinary legislative procedure**
 - a list of files on which Parliament has not yet adopted a first reading position and on which work should resume (Annex I, part A), and;
 - a list of files on which Parliament has already adopted a first reading position and which are awaiting Council's first reading position (Annex I, part B);
- a list of files under **other procedures (NLE, CNS, APP, and INL)** on which Parliament has not yet adopted a position and on which work should resume (Annex II);
- a list of files which **Parliament invites the Commission to withdraw** (Annex III).

I would be grateful if you could submit these elements to the Conference of Presidents for decision, before communicating them to the President of the Commission and the President of the Council.

III. Delegated and implementing acts

Building on the transitional measures decided by plenary on 10 April 2024 to allow former associated committees, in certain circumstances, to remain involved in the examination and adoption of a draft legislative act until its final adoption, the CCC considered, at its meeting on 8 October 2024 that in the light of the close and direct link between a legislative act and the subsequent delegated/implementing acts originating from that act, similar transition measures should apply for delegated and implementing acts.

Accordingly, when a legislative act was adopted by Parliament under the procedure providing for associated committees, the notion of “committee responsible for the basic act” shall also include the former associated committee.

This would mean that the delegated act or draft implementing act/measure shall also be referred to the former associated committee, which may draw up proposals on matters falling within its exclusive competence, as defined in the context of the adoption of the basic legislative act, within a deadline set by the Chair of the former lead committee. If the former lead committee fails to accept these proposals, the President may authorise the former associated committee with exclusive competences to table a motion for a resolution in plenary.

This clause shall lapse if new legislation revising the basic act in question is adopted, or at the latest at the end of the current parliamentary term.
