Your statements and the positions of the EU, most recently at the EU-Israel Association Council on 24 February, are understood as support for the Israeli government and as an abandonment of the Palestinian civilian population.

On the 24th day of our hunger strike by « Hungry of Justice in Palestine », we would like to inform you that we will be in Brussels from 23 to 24 April.

This European citizens' movement is apolitical, secular and has no labels other than that of demanding that the EU respect its legal obligations in line with the opinions of the ICJ, the IPC and the UN.

It is up to you, according to the international and criminal lawyers who advise us, to use all the levers available to the European Union to put economic, legal and moral pressure on this Israeli government, which is openly flouting international, humanitarian, war and human rights law.

As you are well aware, this is not a question of a 'war of civilisation against barbarism', as the Israeli Prime Minister repeats, without reacting in kind, but, as the International Court of Justice, the guardian of international law, affirms, of a plausible situation of genocide, in a situation of occupation of Palestinian territory deemed illegal. Since our return from Gaza, we, the health workers who witnessed it, have testified to the existence of genocide that meets the 5 criteria of the 1948 Genocide Convention, with clear genocidal intent on the ground.

Is it right not to acknowledge this, or to put in place the necessary measures to put an end to these atrocities, which are fuelling the stigmatisation and ostracisation of the religious communities concerned?

Do you think that denying the legal and historical evidence of the impact of colonisation on the minds of the many European citizens who lived through it is in keeping with the marvellous human and ethical values that enabled the founders to create this wonderful European structure? Is the European Union not in the process of undermining its very foundation: the rule of law?

What can we say when our Palestinian medical colleagues tell us that their people have been suffering and dying for decades, and in an unimaginable way since October 2023, 'because of our silence and hypocrisy, as in 1939-45, the origin of their situation since 1948'? What can we say when they tell us: 'Thank you for standing by us in Gaza and the West Bank, but go back home, because to take care of us, your politicians must come out of their silence and respect the rights they state but do not apply'?

Madam President, this is a very serious moment, and it is up to you to dare to speak out clearly, followed by concrete action, such as respecting the arrest warrants, stopping the delivery of arms or components, applying Article 2 of the Treaty on Economic Cooperation, recognising the State of Palestine, banning all products from illegal settlements in occupied Palestinian territory, and using all the other levers available to the European Union.
